Consider/Approve Alternate Mooring Inspection Options: Kelly contacted Marshal Hanks regarding the consideration to dive on the mooring tackle as an inspection alternative. Currently, too many people are non-compliant, due to the unavailability and lack of vendors. Considerations that were discussed: how many years would a dive inspection be needed. Currently require every 3 years. What about when a mooring changes hands? Should we require another inspection? New tackle is required to be inspected before going in.
