The Committee discussed the LED light fixtures. Stubenvoll has been working with Innovative LED on an estimate

Motion: (Birmingham/Sohns) to order the light fixtures for \$14,707. <u>Carried.</u>

The committee reviewed the estimates for the cabinetry. Both companies included open lockers, would prefer closed, lockable lockers. Need to also clarify whether both are quoting the same wood grain laminate.

**Charging Station Estimates:** Estimates were received from Harv's Electric and Baylake Electric. Each estimate included options for various locations. Baylake's estimate includes the installation of an LED light off the garage.
