Somerhalder suggested advertising with local contractors. The DNR needs to sign off on the trimming, therefore delayed. The bid walk through will be happening in early May. The DNR will sign off within 30 days. Anticipate late June or early July to begin construction.

Young Eagles is scheduled for May 21. Volunteers are organized and Alexanders will be catering. Jon Neville will be back next week and will begin notifying the neighbors. The EAA requires volunteers to complete a Homeland Security background check. The EAA chapter polices that and it is the responsibility of the pilot. Will need Brett to resend links.
