- o Envisions working with the office between meetings on the priorities that the board sets
- o Need to get up to speed on the project as to what it means/direction needed
- o Within 30 days make regular presentations on the projects
- o Attend meetings as appropriate
- o Authority will be determined by board.
- o Coordinating projects 8-12 hours/week with weekly reports, project dependent

Robert E. Lee and Associates Inc. - Jarred Schmidt and Gayle Lindenberg

- o Not to be considered a substitute for Clerk or Administrator
- O Services: engineering, grant writing, municipal engineering, initial budgeting through design implementation, survey staff, environmental wetlands, native restoration. Heavy civil, highway, wastewater and water engineering. Administrative services is not the best use. A cooperative approach with Kufrin may be a better match. Strictly project management is \$90 to low \$100's for an hourly rate. In Luxemberg they acted more like an administrator. Hobart has an administrator but still can Lee facilitated the project.

Determination of Project Consultant: Motion: (McKesson, Skare) to engage Bob Kufrin until the end of the year and get some of these projects started. Direction would be given by Beth to Kufrin. <u>Carried with Hackbarth opposed.</u> The current funds available is \$20,000.
