Consideration to replace Gibraltar Old Town Hall twin furnaces: Proposals received were from: Wulf Brothers \$5,340.00, Synergy \$5,136.00 and 2 proposals from Eagle Mechanical, Inc. \$3,991 or with an optional upgrade to 2-stage with variable speed ECM blower motors increase of \$1,853, total \$5,844.

Motion: (Hackbarth, Sohns) to accept the proposal from Eagle Mechanical 2 stage with variable speed ECM blower motors at a cost of \$5,844 with the addition of a programmable thermostat. <u>Carried with Merkel opposed.</u>

Determination of funding source for Gibraltar Old Town Hall furnace replacements: The 2017 budget has a line item of \$4,100 slated for the replacement of the furnaces. *Motion: (Hackbarth, Sohns) to fund the furnace replacements for the Gibraltar Old Town Hall from the Capital Improvement fund and at a separate meeting move the \$4100 to the CIP from the Town Hall budget. <u>Carried</u>*
