New Town Shop Walk-through Discussion:

- Reinhard needs to complete the air compressor testing
- Need to locate the extra chips for epoxy flooring
- Door Guard has most of the alarms connected.
- Add concrete sealing to maintenance calendar every fall.
- Cold Storage has been resealed.

Review PBS Billing Statement:

- State of WI plan review bill from March 2016 for \$975 to be paid directly, need to see actual invoice. Check plan review
- Extras and closeout fees from Baudhuin over bid. What are the permit and closeout fees?
- Why are Van's invoices coming out of contingency \$1640.60 May be due to vapor barrier needed to be added in shower room (material and labor). Van's bid for material only, not labor

 - o 1/25/17 \$192.01 Hardware from LaForce
 - o 1/5/17 \$2427.56 Ceiling Tile
- Harv's Change Order \$2780 to connect generator

Charter Estimate for New Town Shop: Stubenvoll met with Charter. Charter will be laying 2 inch conduit for the regular install price of \$99 to the pole behind the fire station.

Compressor Location: The location of the air compressor has raised questions. It has passed inspections.
