**Sam Healy Tour Operator Request:** Franke stated an operator should have at least 100 hours of flight time to operate commercially. Experience level needs to be established for the make and model of the aircraft. He currently does not have a letter of authorization from the FAA, to have a point of origin airport with in a 25-mile radius. Minimum guidelines for commercial operations needs to be established. *Motion: (Lecy, Somerhalder) to deny Sam Healy Tour Operator Request. <u>Carried.</u>* 

**Review Insurance Requirements on Tour Operator Agreement:** Marty discussed insurance with a broker about coverage for tour operators. Combined single limit coverage that also applies to personal injury should be required.

**Fencing AWOS Area:** Unable to discuss as item was not on the agenda to remove from table. Mrs. Ross suggested the tree eaters may have done the damage to the AWOS area.

Airport report: Lecy has been in contact with an insurance agent and is waiting on an update. Somerhalder researched the height ordinance. County did not have on file. Somerhalder located a map in his old files from 1995. It doesn't match the map attached to the ordinance from 1973. The height ordinance wouldn't need to be recorded with the register of deeds. The BOA may have it recorded. The map was updated in 1995 and would be the current map for the ordinance. Fiorato asked how would land purchasers know that an ordinance like this one exists. Easement opportunities need to be looked into.

Beth suggested a recommendation be brought forward to the Town/Village Boards during their joint meeting.
