**Call to order:** Dick Skare called the regular meeting to order at 7:00 p.m.

# **Committee Reports:**

**Parks & Lands:** Brian Hackbarth reported the December committee was cancelled due to weather. At this time of year-end spending is a priority.

**Fire Department/EMR:** Fire Chief Anderson stated ice is never considered safe. The department will be having a Cert 1 class, that is the class above entry level. An EMR class is starting tomorrow night in Sturgeon Bay.

**Noble House:** Barb McKesson stated the museum is closed for the winter. About 60 people participated in the tree lighting followed by beverages at the Blue Horse. GHA is gearing up for "All Things Chocolate" fundraiser during the Winter Festival the first weekend in February. The chocolate can be found in the Old Town Hall.

Watershed: Linda Merline stated there nothing to report.

Airport: No report.

**Planning:** Linda Merline stated zoning issues were discussed with Kufrin Consulting at last night's meeting. **Harbor Commission:** No report.

**Room Tax:** Weddig stated the commission met the week before Christmas. The zone is up a minimum 3.2% for the year with the current reporting.

Building Committee: Karl Stubenvoll stated the committee did not meet last month.

Clerk Report: Beth Hagen stated the Spring Election deadline for nomination papers was January 2<sup>nd</sup>. Door County Coastal Byways Council: Beth Hagen reported that a presentation by Gundrum – AKG Vineyard was given requesting a letter of support to be given to the Door County Board of Adjustment for a denied conditional use permit. The request was denied by the council as it felt it was not appropriate for the council as an intergovernmental organization to take a position on private businesses. The next meeting is on January 26<sup>th</sup> at the Gibraltar Town Center at 8:30 a.m.

**Chairman:** Dick Skare spoke with the DOT and there are informational pages on how businesses can be prepared for construction on their DOT website. The website address is: wisconsin.gov/Pages/projects/intogether/default.aspx.

**County Board:** Supervisor Steve Sohns reported that 1/18 from 4-6 p.m. will be the Grand Opening of the Community Center. This will be the only opportunity to look at the whole building. Preliminary discussions and an engineering study to update the ambulance station on Washington Island were had.

### **Public Comment:**

- o Paul Apfelbach sent a letter of concern on the relocation of the storm drain at the beach.
- o Jayson Merkel asked how the town will be handling the felled trees at Sunset Park.

# DOT Hwy 42 project update and actions items:

- Crosswalks: Keep existing crosswalk at NorDoor Sports, 2 islands, YMCA and Cty. F locations; a quick review of the map should be done prior to sending to the DOT. *Motion: (Hackbarth, McKesson) to move forward with the crosswalk locations per discussion and that the final will be reviewed by the office.* Carried
- Lighting final design: Andrew stated the plan is 98% complete. Ken to get beach plan to adjust the lighting plan. The scope of the plan is Hwy 42 from Bluff Lane to YMCA and include Shore and Evergreen Roads. Motion: (Hackbarth, Sohns) to move forward with the lighting plan from along the highway from Bluff Lane up to the YMCA as per the map with any adjustments between the current 90% and 100% for the crosswalks or beach. Carried

**Parking lot project:** Skare stated that due to weather necessary information gathering was delayed.

Special Event Request: FCCA Winter Festival February 2-4, 2018, Use of Gibraltar Town Hall, Clark Park, signage, parking lot and road closures, temporary structures, trolley stop signage, portapotties, and fireworks permit: Bob Spielman requesting use of Clark Park, Old Town Hall (GHA), delete Alibi Parking Lot. Trolley time will be extended to the end of the fireworks. Sandwich boards for the 3<sup>rd</sup>. Tent goes up on Thursday the 1<sup>st</sup> and stay up until Monday the 5<sup>th</sup>. Road closing request from Spruce and Maple to Spruce and Cedar., need access to both boat ramps. Deputies 10 a.m. -5 p.m. for ID's. Games will be in the tent, Clark Park, on the ice and closed streets. Fireworks more likely to be at 5:45 p.m. Fire rings will have extinguishers and attendants. Fun run is scheduled for Sunday. The fire department and law enforcement will be coordinated as necessary. *Motion: (Daubner, Hackbarth) to approve as amended (see discussion above). Carried*

Approve application for Bad Eleven Provisions, LLC Class "A" / "Class A" liquor license for 2017-2018, 4149 Hwy 42, Parcel # 014-00002 and #014-00003 Scott Schmitz, Agent: The board reviewed the application. Motion: (Hackbarth, Sohns) to grant the Class "A" / "Class A" liquor licensed to Bad Eleven Provisions for the 2 tax parcels listed. Carried

Petition for Grant of Variance: Jeff and Janet Drajesk, 9624 CTH A, Parcel # 014-02-26312723G, building setback from side lot line of principle structure: Linda Merline gave an overview of the petition. Unique property limitations: building was already encroaching on the line, hardship was the rock ledge. There is no harm to the public interest. The commission recommended support of the grant of variance. Motion: (McKesson, Skare) to recommend support of the Petition for Grant of Variance: Jeff and Janet Drajesk, 9624 CTH A, Parcel # 014-02-26312723G, building setback from side lot line of principle structure. - A. <u>DOT Action items 1-5:</u> Implementation of decisions made.
- B. <u>Wayfinding signage design/permitting</u>: Cedar street plaza to be removed. The three blocks on Main from main intersection to Sunset Park, need more public input. Through the choke point on Main

west of Cottage Row only have parking on 1 side. This is a preliminary design where the option of the diagonal parking could be considered. Andrew to check with Alex on how much to widen to get the diagonal parking. FCSD1 to be redoing the electric at that station. Phasing of parts of the plan may be beneficial. Historical signage should be pedestal type, delete the other examples. Barb to send Andrew sample ideas. Lighting plan add bollards to the walkway to rear boat and auto parking lot on the west side of the lot that leads to the Town Center.

<u>Pedestrian enhancements</u> – Paint your own fish. Is thermoplastic slippery? Cost 18" wide \$36.90/foot. \$80 per square yard in Dane County, \$125/yard in Marinette. Durability and maintenance is a factor.

<u>Marigold relocation:</u> Take out commercial district planters. Insert under the previous page of commercial district planters, Sohns planter design and have water recommendation. Under Fish Creek Park make sure the design takes into account the multimodal path. On substituted page omit 3-5

<u>Wayfinding signs</u>: Too cookie cutter, too many entrances. Destination signage is good. Local business signs. Add a disclaimer that there may be customized signage. Gateway signs may be left. Listing businesses not fair but destinations are good. Add a sign to Robertoy's and A/42. A & F community wayfinding, not a business. Discuss eliminating local business signage on town standards.

Get back new version for 1 last redline in a couple weeks.

Adoption of Amended and Restated Ordinance No. 1982-5 Food Trucks, Hawkers and Peddlers Prohibited: The ordinance is being amended and restated to include merchandise and expand for the whole town. Change penalty to \$100/\$500. How to address farm markets/catering and enforcement was questioned. Seller's permits need to be scrutinized. *Motion: (McKesson, Sohns) accept the Amended and Restated Ordinance No. 1982-05 Food Trucks, Hawkers, and Peddlers as amended. The motion was withdrawn.* Put on the 1/10 agenda.
