## **SEH Projects**

- o Biofilter Options: Jeff Saxby stated that Mark Mickelson contacted Contech Engineered Solutions LLC. The Filterra Bioscape has an initial cost of \$450,000. Saxby felt this is cost ineffective, takes up the beach property along with plantings and lacks regulation. Skare spoke to Don Prust of Baileys Harbor who has worked with Steve Parent on a wrapped pipe that filters out solids. Jeff stated it is most realistic to run the pipe into the bay. McKesson stated something must be done about the geese. Recommendation not to do the biofilter. Flat rock at the end of the pipe to control erosion. *Motion: (Sohns, Johnson) to forego the biofilter system and go with the original plan to put the pipe to the beach. Carried*
- **o** Bath House update and choices needed: Pat Fehrenbach has incorporated the latest changes from Rick Toyne.
  - o Will contact Brett Guillet regarding plan approval
  - o Current contract is being modified (may not be financial difference but drawings/details)
  - O Changing room are to have full height walls with doors facing forward the same as the restrooms
  - o All the wood siding stained on both sides
  - O Cost for additional insulation for 4 seasons use
  - o Asphalt shingles architectural grade.
  - o FRP, ceilings, epoxy paint floors, epoxy cove
  - o Floor drains in each bathroom and changing room
  - o Catch for sand in the drain system
  - o Dana would like mechanical sink fixtures
  - o Hooks (2) heavy duty in changing and toilet rooms
  - o Fold down bench in each bathroom
  - o 1 bath to have wall mount baby changing station
  - o Changing rooms to have bench same as toilet rooms
  - O Changing room walls to be similar to toilet room walls and run full height to trusses above for potential enclosure
  - o Changing room doors to face west the same as toilet rooms
  - o Ability to drain water fountain for off season
  - o Mirror above sink
  - o Manual soap dispenser
  - o Put in electric for hand dryers Dyson
  - o Awning style window with frosted glass at approximately 5' high
  - o Closers on doors with locks and occupancy indicators
  - o Exterior doors hollow metal doors with a fiberglass finish
  - Fold down bench in changing rooms
  - o Commercial aluminum bulletin board
  - o Water fountain
  - o Round columns hand peeled column
  - o Siding rough or smooth?
  - o Foot washing station with a shower spray at the north side free standing unit

- o Nothing beyond building setback
- o Bollards for sidewalk at least run conduit
- o Lamp at parking area
- o Construction documents being worked on, periodic reviews
- o End goal finish 7/4
- o Have Baudhuin do layout, elevations, etc.
