

TOWN OF GIBRALTAR
ORDINANCE GOVERNING PARKING, PICNICKING AND LITTERING
ORDINANCE NO. 1990-02

The Town of Gibraltar does hereby, in accordance with Wisconsin State Statutes, ordain as follows:

Ordinance No. 1982-04 is hereby revoked and recreated by this new ordinance.

SECTION I

- 1.1 This ordinance hereby incorporates the definitions found in Chapters 340, 345 and Chapter 66 of the Wisconsin Statutes.
- 1.2 This ordinance incorporates all portions of the Wisconsin Statutes found in Chapters 340 through, and including, Chapters 348 and 349 as they relate to parking, together with all rules relating to both criminal and civil liability.

SECTION II
PARKING PROHIBITED

- 2.1 It shall be unlawful for any person or persons to park and leave standing any vehicle, whether attended or unattended, on any access roads or dead end roads leading to the waters of Green Bay in the Town of Gibraltar between the hours of 11:00 P.M. and 6:00 A.M. in areas where “no parking” signs depicting these hours are erected giving notice thereof. This ordinance specifically applies to Ula Street and Ula Street shall be treated the same as any other street covered by this ordinance. By this new ordinance, Ordinances No. 82-4 and 87-10 are hereby rescinded and replaced by this new ordinance.

SECTION III
PICNICKING PROHIBITED

- 3.1 It shall be unlawful for any person or persons to picnic on any fire access roads or dead end roads at any time where “no picnicking” signs are erected giving notice thereof.
- 3.2 No person or persons shall throw or deposit any paper, glass, metal, rubbish or any other type of debris or waste material upon any fire access road or dead end road leading to the waters of Green Bay or upon the surface of the waters of Green Bay at any time.

SECTION IV
PENALTY

- 4.1 Any person or persons violating any of the provisions of this ordinance shall be fined \$10 for each offense. A separate offense shall be deemed committed on each day during or on which a violation occurs or continues. In addition to the forfeiture, any person violating any provisions of this ordinance shall be required to pay all the costs and other penalties as provided under Chapter 345 of the Wisconsin Statutes.
- 4.1 The constable for the Town of Gibraltar and nay and all deputy sheriffs for the County of Door shall issue a citation to the owners or operators of illegally parked vehicles and trailers, which citation shall inform the recipient of the citation as to the procedure for

paying the penalty prescribed herein and the consequences of not paying the penalty and which shall also note the following information:

- A. Identification of the location of the space where the vehicle or trailer is illegally parked and/or an approximate street address.
- B. The license plate number and the state of issuance of the illegally parked vehicle or trailer.
- C. The date and time in which the vehicle is observed to be illegally parked.
- D. Any other facts that may be relevant to the issuance of the citation.

SECTION V
EXCEPTIONS

5.1 The exceptions set forth in Section 346.50 of the Wisconsin Statutes are hereby incorporated herein.

SECTION VI
ENFORCEMENT

6.1 This chapter shall be enforced according to Sections 345.20 up to and including Sections 345.53 and Chapter 799 of the Wisconsin Statutes.

BE IT RESOLVED that the foregoing ordinance be adopted and shall become effective upon passage and publication.
