**Project bank draw approval in the amount of \$451,512.44:** Hagen stated this amount is for project costs paid out since August. *Motion: (Sohns, McKesson) to approve a bank draw in the amount of \$451,512,44 for project costs. Carried* 

**Determination of used streetlights - sale etc.:** The total number of lamps is not known yet. It was previously discussed that the town would keep a number of lights for parts and then sell the balance. The town will keep 8. There are individuals who have expressed interest in purchasing multiple streetlights. The town cannot control where they are installed. It would be best to offer to locally (Gibraltar) at a lower price as the Gibraltar individuals have already paid for them once through special assessments. Steve provided examples of used streetlights currently available online. Steve suggested a sale price of \$150 per lamp. Post a notice of availability in town and on website.

Motion: (Johnson, Luettgen) that we keep 8 for parts and (local cost \$150) offer those that have expressed an interest in their choice of poles and we offer the rest of them by the website and other communications that we do to the community and whatever is left to the auction site and get rid of them.
