## TOWN OF GIBRALTAR ORDINANCE 2020- 03

Ordinance Regarding the Designation of Handicapped Parking Spaces in the Town of Gibraltar, Door County, Wisconsin.

The Town Board of the Town of Gibraltar does ordain as follows:

**Section 1:** Authority. The Town Board of the Town of Gibraltar has the specific authority, powers and duties pursuant to Chapter 60 of Wisconsin Statutes and the Town's adoption of Village powers pursuant to Wisconsin Statutes Section 60.10, to regulate and control certain uses, activities and operations in the Town of Gibraltar.

**Section 2.** The Addition of Handicapped Parking Spaces in the Town of Gibraltar. The Town Board of Gibraltar hereby establishes areas which are designated as handicapped-parking only. Such areas shall be designated by "Handicapped Parking" markings painted on the pavement.

It shall be unlawful for any vehicle without proper handicapped designations to park in places designated for handicapped parking.

Additional handicapped parking spaces shall be designated in the following locations:

**Section 3. Intent.** The intent of this ordinance is for the health, safety and welfare of Town residents.

**Section 4. Enforcement.** This ordinance shall be enforced by any law enforcement officer authorized to enforce laws of the State of Wisconsin.

## Section 5. Violations.

## 1. Citations.

This ordinance shall be enforced by the issuance of a citation by the Gibraltar Police Department or any person authorized to do so by the Town Board. The Town will prosecute the violation according to Wisconsin law and Town ordinance.

## 2. Penalties.

Any person who shall violate any provision of this ordinance shall be subject to a forfeiture of \$100 plus costs for the first offense and shall be subject to a forfeiture up to \$500 plus costs for subsequent offenses.

**Section 6. Severability.** The provision of this ordinance shall be deemed severable and it is expressly declared that the Town would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to the other person's circumstance shall not be deemed affected.

**Section 7. Effective Date.** This ordinance shall be effective upon passage and publication.
