December 30, 2020 for Immediate release: COVID-19 Vaccine for Healthcare Workers

The first groups prioritized by national, state, and local vaccination plans to receive the COVID-19 vaccine are healthcare workers and residents of long-term care facilities. Long term care facilities (nursing homes and assisted living facilities) are involved with a state program matching them to pharmacy partners to receive their COVID-19 vaccine, and this is underway. Additionally, local healthcare systems in Door County have begun to vaccinate their own eligible healthcare workers.

Door County Public Health anticipates receiving COVID-19 vaccine in January. At this time, we are planning COVID-19 vaccination for healthcare workers not associated with healthcare systems receiving their own vaccine supply. We need to identify these healthcare workers to plan our vaccination clinics and possible collaboration with healthcare partners in this effort.
