Spring Election is Tuesday, April 6

A reminder that the Spring Election is Tuesday, April 6. Polls are located at the Town Center (4097 Main Street) and open from 7 am - 8 pm. Voters must show an acceptable photo ID to receive a ballot for all elections. You can learn more about Wisconsin's Voter Photo ID Law and the acceptable forms of photo ID by visiting **Bringlt.Wi.gov**.

Voters who are not currently registered can register to vote at the polls on Election Day. (You cannot register the Saturday, Sunday or Monday before an election.) Voters must reside at their address for at least 28 days by Election Day.

When registering to vote, please bring Proof of Residence. All Proof of residence documents must include the voter's name and current residential address. The most common types of Proof of Residence documents include:

- A current and valid State of Wisconsin Driver License or State ID card.
- Any other official identification card or license issued by a Wisconsin governmental body or unit.
- Any identification card issued by an employer in the normal course of business and bearing a photo of the card holder, but not including a business card.
- A real estate tax bill or receipt for the current year or the year preceding the date of the election.
- A university, college or technical college identification card (must include photo) ONLY if the voter provides a fee receipt dated within the last 9 months or the institution provides a certified housing list to the municipal clerk.
- A gas, electric or telephone service statement (utility bill) for the period commencing no earlier than 90 days before Election Day.
- A bank or credit card statement.
- A paycheck or paystub.
- A check or other document issued by a unit of government.
- A residential lease that is effective on date of registration.

This is not a comprehensive list, but categories of the most common types used by voters.
