Petition for Conditional Use Permit: Estes (Cherry Hut) to Establish a Greenhouse: Jason Estes from the Door County Cherry Hut is requesting a conditional use permit for a greenhouse. It is a hydroponic greenhouse made out of a recycled shipping container. The noise from the unit should be minimal. The unit will be located behind the building with retail will be from the market. Will be able to provide fresh produce year-round.

Ordinance to Ban Certain Noxious Weeds and Terrestrial Invasive Plants: The intent of the ordinance is to provide education and not be heavy-handed. This ordinance targets 4 species: Phragmites, Wild Parsnip, Commonteasel and Japanese Knotweed.

In the past, the Commission has work with Parks and Lands to help control the spread of invasive species. *Motion: (Pillat, Blackwood) to allow staff to move forward with the Noxious weed ordinance. <u>Carried.</u>*

Consideration of Re-Petitioning the County to add Miniature Golf to Village Commercial Zoning:

There is an individual interested in establishing a miniature golf course in Village Commercial. The Town Board has asked the Plan Commission to consider whether to pursue this again.

Motion: (Pillat, Blackwood) to not re-petition the County. Carried.
