

PRESENT CEMETERY RULES AND REGULATIONS

⇒ In the 2007 Second Addition to Blossomberg Cemetery all headstones must be flush with the ground. (Per Department of Natural Resources requirements.)

⇒ It is hereby ordained, that no person shall plant, cut or trim any herbage of any kind, or place or erect any monument or other memorial stone, or any other structure of any kind or build or construct any foundation therefore, or form, grade, dig up or deposit any material of any kind, upon any burial lot or other portion of the said Town Cemetery known as Blossomberg Cemetery; except by the consent or direction of the Town Board of the Town of Gibraltar or any member thereof; this limitation is intended to prevent memorial stones unusual in design, composition, or size, and is not intended to prevent those memorial stones similar to stones now existing in the said cemetery; and,

It is further ordained that no fences or enclosures shall be placed on any lot or around any lot whatsoever.

This ordinance is ordained and promulgated for the purpose of facilitating the up-keep of said cemetery, and for the purpose of keeping said cemetery in harmony and fitting with its present status and surroundings.

⇒ **WHEREAS**, the Town of Gibraltar had previously limited the sale of burial sites to Town of Gibraltar residents and/or property owners; and,

WHEREAS, the Town Board of the Town of Gibraltar did extend the right to purchase burial sites in Blossomberg Cemetery to the mothers, fathers, sons and daughters of persons buried in Blossomberg Cemetery prior to September, 1982, by Resolution 82-2; and,

WHEREAS, the Town Board does now wish to further extend the right to purchase such burial sites, to include certain surviving spouses of persons buried in Blossomberg Cemetery.

THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Gibraltar, that the sale of burial sites in Blossomberg Cemetery is hereby extended to include surviving spouses of persons buried in Blossomberg Cemetery prior to the date of this Resolution, provided that the purchaser and the deceased person were legally married at the time of the deceased person's death.

⇒ **ONE HEADSTONE PER SITE**

1 Lot = 8 burial sites

1 site = 1 body and 5 cremations OR 6 cremations, 4' X 10'-soil depth dependent.

⇒ Present cost of burial site is \$600 as of January 1, 2022 for a resident/property owner.
Present cost of a burial site is \$1200 as of January 1, 2022 for a non-property owner.
Present cost of a cremation site is \$150 as of January 1, 2022 for a resident/property owner.
Present cost of a cremation site is \$300 as of January 1, 2022 for a non-property owner.

A full body burial costs \$400. (Cost to be buried.)

A cremation burial costs \$150. (Cost to be buried.)

A person/family is limited to the purchase of 8 sites, whether cremation or full body burial sites.
