# ORDINANCE 2023-01

## SUPERINTENDENCE OF TOWN INDEBTEDNESS

# Ordinance 2023-01 Identified as Superintendence of Town Indebtedness shall repeal and replace any previous ordinance (s) in whole or part or any other ordinance contradicting to this new ordinance.

The Town Board of Gibraltar, in the County of Door, State of Wisconsin, does hereby ordain as follows:

## Authority:

The Board of Supervisors of the Town of Gibraltar is granted authority for the adopting this ordinance under its general 60.10(2)(c) and 60.22(3), Wisconsin Statutes. The Town Board Adopts this Ordinance under its general village powers authority and 66.1014 of the Wisconsin Statutes, 2917 Act 59

## **Definitions:**

<u>Superintendence</u>: Management or an arrangement of an activity <u>Indebtedness</u>: condition of owing <u>Ordinance</u>: A piece of legislation enacted by a Municipal Authority <u>License</u>: A form of authority to own or use something, do a particular thing, or carry on a trade. <u>Permit</u>: an official document giving someone authorization to do something. <u>Transient</u>: Lasting only for a short time.

#### **General provisions:**

The Town of Gibraltar offers various services to its community, providing guidance, structure, and governance to all residents and businesses, both permanent and transients. To maintain peace and order, the Town of Gibraltar Board has installed various rules and ordinances. These ordinances are in place to give resources to our public safety officers as well as establish funding to maintain the Towns infrastructure on both land and water.

The Town Board of Gibraltar has established a set of licenses and permits to govern our liquor, Short Term Rental, Businesses, Public Safety, construction, and development.

## Violation:

Anyone who is required to pay a utility, obtain and pay a permit, obtain and pay a license, pay a traffic violation, pay personal property taxes, rent town facilities, or obtain and pay moorings or dock slips, shall be aware the Town of Gibraltar reserves the right to suspend, revoke, or not issue any or all of the afore mentioned requirements until any license, permit, utility, or any other fees or monies owed to the Town, or any combination of requirements are met.

#### **Enforcement:**

The Town of Gibraltar shall review status for all property owners, and businesses, and shall not issue any Permits, licenses, moorings, slips, or special event, including renting town buildings, until the town has

been made whole any outstanding license, permit, citation, or utilities, including and late fees or forfeitures that are unpaid or required by Town Ordinance or State Statutes.

#### Severability

If any of this Ordinance be declared invalid or unconstitutional by a court of competent jurisdiction, such a decision shall not affect the validity of any other provisions of this ordinance.
