Advancing Public Safety: Gibraltar Police Chief Roesch's Innovative Drone Utilization

In an era characterized by rapid technological advancements, law enforcement agencies around the world are harnessing the power of cutting-edge tools to enhance public safety and efficiency. One remarkable example of this trend can be found in Gibraltar, where Police Chief Roesch has taken a pioneering step by incorporating drones into the department's operations. This innovative approach has yielded significant benefits, as showcased by the recent deployment of a drone to manage an uncontrolled brush fire and to rescue a lost skier.

One of the most impressive applications of the drone technology under Chief Roesch's leadership was its crucial role in monitoring and managing an uncontrolled brush fire on Juddville Road, in close proximity to a drilling and blasting company. The ability of drones to provide real-time aerial views proved invaluable to emergency personnel. By granting them an elevated perspective of the scene, the drone enabled accurate assessments of the fire's extent and potential risks, thereby allowing fire crews to develop an effective containment strategy. The deployment of the drone not only expedited the process of surveying the area for potential dangers but also ensured the safety of first responders by providing them with vital situational

Moreover, the success story of Gibraltar's drone deployment extends beyond managing fires. Last January, the drone played a pivotal role in the rescue of a lost skier within Peninsula State Park. By deploying the drone, search teams were able to quickly locate the lost skier and guide him to safety.

The incorporation of drones into law enforcement operations introduces a paradigm shift, providing enhanced capabilities that were once unimaginable. Not only do drones offer a cost-effective solution for reconnaissance and surveillance, but they also minimize risk to personnel and maximize efficiency in emergency response situations. As technology continues to evolve, it is clear that law enforcement agencies that embrace such advancements are better equipped to safeguard their communities and respond effectively to a wide range of challenges

Committee Chronicles: Headlines and Announcements

Fish Creek Park – Then and Now (courtesy of Linda Merline)

Then: 25 years ago, in July 1998, the Town of Gibraltar was on the verge of purchasing 27.9 acres that is part of the Fred Welcker property in the center of the community of Fish Creek. The creek and its wetlands, for which the community was named, ran right through the property. The purpose of buying the property was to preserve the land, including the creek and its wetlands, and possibly turn the land into a park.

Now: 25 years later, in July 2023. The Welcker property has since become Fish Creek Park, and the Town of Gibraltar is now on the verge of purchasing 118.76 acres of the Redmann family property to expand the park. A portion of the Redmann property adjoins Fish Creek Park to the south below the bluff and contains an upstream section of the creek and its wetlands. The purchase also extends the park with land located on top of the bluff. A multi-moto trail will connect the park below to the park above the bluff. The purpose of buying the property is the same as 25 years ago, to preserve the land, including the creek and its wetlands, and turn the land into an expansion of Fish Creek Park.

Then: Initial ideas for the land were a park with hiking, biking, and cross country ski trails, but no specific plans had been made yet at the time the property was being purchased.

Now: Initial ideas for the new expansion to Fish Creek Park are to restore fish habitat and create a multi-moto trail that would be part of a longer trail that would connect with Egg Harbor to the south and Ephraim to the north, but no specific plans have been made yet as the Town proceeds with the purchase of the property.

Then: 25 years ago, in an article about the Welcker land purchase in the Door County Advocate, of July 28, 1998, Wallis Parker, the executor of the estate of her uncle, Fred Welcker, commented that the creek had no fish "... it has been barren since changes were made in the highway that would require fish to jump at least a foot while traveling upstream."

Now:25 years later the Town of Gibraltar has completed the installation of a fish ladder, so instead of jumping, the fish can go up three small steps and have access to the wetlands upstream. The Town used a DNR River Management Grant to fund the creation of the fish ladder.

Now: Watch for opportunities for the public to be involved in decisions on how the new section of Fish Creek Park is used.

PARKS & LANDS focus is on making our village a pleasant place to relax, view a sunset, or enjoy the water. This year's opportunities allowed us to improve areas on our goal list. The first is the replacement of our little kiddie's playground at the beach; with numerous restrictions, it is now in place and used constantly. Watch for the rubber surface coming this fall from a grant from Destination Door County. We also have three deluxe benches coming to Noble Square, a combination of concrete and recycled plastic should keep them in use for generations to come. Two replacement trees have been placed at Blossomberg Cemetery; it is only with the support of our visitors and community that we can replace the numerous dead ash trees.

Another successful Weed Warriors event helped remove large amounts of Dames Rocket at Fish Creek Park; our efforts from one year to the next are starting to show signs of improvement. Pick up an Invasive Plant Flyer at the town's community board for more information.

We also participated in Gibraltar's Fog program, along with the Watershed team, and students came to learn about our Creek and aid us in planting swamp oak along the Creek's bank to return shade, a part of our reforestation project. Any blue tubes are the new plantings. These same students helped mulch trees throughout our town parks. It was a fun day, and we are sure some future naturalists will be among these dedicated students.

December's loss of our dear Mary Ann Blahnik marked 47 seasons of caring for the **Chamber's** Island Lighthouse property with her husband, Joel. We applaud their dedication to the safekeeping of this remarkable place. We miss Mary Ann's kind spirit and enduring passion for preserving history and making all visitors feel welcome. We also would like to thank Leon & Sharon Zellner, who have agreed to take on the duties and donate numerous hours to keep our Chambers Island Lighthouse open for the season.
