# **Unleashing Expertise:**

Meet the Canine Search Unit of the Missing/Endangered Response Team (MERT)

When it comes to search and rescue, every second counts. In Door County, the Canine Search and Rescue Unit of the Gibraltar Fire and Rescue Team, a crucial component of the Missing/Endangered Response Team (MERT), plays a pivotal role in locating lost individuals, runaways, and other missing persons. Conceived by Town of Gibraltar Fire Chief Andy Bertges and operated through the Door County Department of Emergency Management in coordination with the Sheriff's Office, this specialized unit is a testament to the power of partnership between human handlers and their canine companions.

#### The Heart of the Team

At the core of the Canine Search Unit are dedicated dogs and their handlers, who undergo rigorous training to prepare for the diverse challenges of search and rescue operations. Currently, the team includes Officer Tina and her loyal canine partner, TJ. Together, they form a core unit within the Door County Sheriff's Department, but they are far from alone. The team is supported by additional skilled handlers and their dogs, all ready to step in and provide assistance when needed.

#### **Training for Excellence**

The Canine Search Unit is trained in two primary techniques: trailing and air scenting. Trailing involves following a specific scent trail left by an individual, while air scenting allows the dogs to detect the general presence of a person in the area. The dogs' ability to perform these tasks is honed through intense training. New dogs in the program undergo over ten days of training each month, while experienced and certified dogs maintain their skills with six to ten days of training per month.

Bob, a seasoned handler, provides a glimpse into the world of these dedicated canines. His dog Toby is a veteran of the unit, certified in both wilderness and urban search scenarios by multiple agencies. Toby's extensive experience is invaluable, but Bob's younger dog, Ollie, is quickly making a name for himself. Trained since he was just eight weeks old, Ollie is now eight months old and has just passed his first certification test in human trailing. According to Bob, dogs "grow into" their noses around three to four months of age. Ollie's upcoming certification in Green Castle, Indiana will mark a significant milestone in his promising career.

#### **Weathering the Elements**

One of the remarkable aspects of these search dogs is their ability to work in various weather conditions. Rain, for example, can actually enhance their performance. Moisture helps make scents more pronounced, allowing the dogs to track even in challenging environments. Furthermore, the dogs can trace scents from vehicles, as cars leak odors that can attach to surrounding vegetation, allowing the dogs to pick up the trail.

#### A Lifesaving Partnership

The Canine Search Unit exemplifies the extraordinary bond between humans and dogs. With their specialized skills and rigorous training, these canine teams are not just a backup, but a critical component of the Missing/Endangered Response Team. Their contributions are invaluable in ensuring the safety and well-being of individuals in distress, making them true heroes of Door County's search and rescue efforts.

As the Canine Search Unit continues its mission, they remain a symbol of hope and dedication, proving that with the right training and teamwork, even the most elusive scents can lead to a successful recovery.

# **Broadband UPDATE**

The Town of Gibraltar Town Board has approved an agreement with Bertram Communications to install underground high-speed fiber optic cable to all improved parcels in the town. This service includes bringing fiber to every building (one per parcel). With this agreement, the Town will borrow the funds to complete our end of the contract obligation. State Law doesn't allow municipalities to separate debt individually so everyone who pays taxes in Gibraltar will be paying off the debt through the tax process.

Because of the tax implications, the Town Board and Internet Committee have agreed that there will be no cost to have this service brought to every building and installed into a fiber box on the outside, regardless of where their building sits on the parcel. The Internet Committee has been making efforts to reach every improved parcel owner for permission to bring the fiber to premises. Bringing fiber to the premise does not mean that you need to sign up for the service. The contract with Bertram to install fiber is anticipated to be completed in October of 2025. After that time, anyone who decides that they want the service will need to pay out-of-pocket to have it brought to the premises.

For those who receive the service, the Town has negotiated a price lock for three (3) years and a guarantee not to exceed for another seven (7) years. The service is also guaranteed to provide a minimum speed of 250 MBPS (megabytes per second) to both upload and download.



# **Five Years as a Green Tier Legacy Community**

As we celebrate our 5 years as a Green Tier Legacy Community, it's good to look back on the path the Town took to get to this day. It began in 2008, when David Boyd and Dick Skare went to a conference on sustainability. The idea was that you needed to start now to maintain and support your business or municipality if you expected it to remain vibrant in the future. Actions you could take toward this end were environmental, social, and economic.

David and Dick brought these ideas back to the Plan Commission and the Commission under the leadership of Tom Birmingham agreed to look into it. Dave and Renny Lea gave a presentation on The Natural Step program that came out of Sweden. They supported something called Eco Municipalities. Some of us attended local classes in the Natural Step to learn more. Some towns like Bayfield, WI lost no time joining up. In Fish Creek, people were skeptical. The conversation continued for a while and then stopped with no action.

Some years later, Beth Hagen, the Town Clerk, heard about a similar idea closer to home. It was called Green Tier, and it was created by several nonprofits along with the Department of Natural Resources. It began as a framework to help businesses work toward sustainability. It soon spread to include municipalities. It offered incentives to encourage your progress, like preferred status when applying for DNR grants and a network of communities that you could go to for information on common goals. I attended a presentation by the DNR in Egg Harbor, and representatives from Ephraim came and presented to the Plan Commission. The Plan Commission took information to, and consulted with, the Building Committee, the Harbor Commission, Park and Lands and the Town Board. Finally on October 2, 2019, the Town became the 28th Green Tier Legacy Community in the State of Wisconsin. The best news is that you can help make our Green Tier Legacy Community even better by sharing your ideas for how to sustain the Town into the future! Join your neighbors in attending the Green Tier Ad Hoc Committee meetings and become a part of the team that sustains our Town.
