

RESOLUTION NO. 2024-05

RESOLUTION REGARDING THE LYNN H. AND SHARON L. BUSCH REVOCABLE LIVING TRUST DATED SEPTEMBER 17, 2002 ROAD DEDICATION IN THE TOWN OF GIBRALTAR, DOOR COUNTY, WISCONSIN

BY THE TOWN BOARD OF THE TOWN OF GIBRALTAR:

WHEREAS, the Town Board of the Town of Gibraltar, Door County, Wisconsin, by this resolution, adopted by a majority of the Town Board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and declares as follows:

BE IT RESOLVED, that the public way described below and dedicated to the Town in that conveyance of real estate between the Lynn H. and Sharon L. Busch Revocable Living Trust dated September 17, 2002, as grantor, and the Town of Gibraltar, as grantee, dated October 2, 2024, and recorded in the office of the Register of Deeds for Door County, Wisconsin, on October 14, 2024, as Document No. 872037 is accepted pursuant to s. 66.1024, Wis. Stats.

BE IT FURTHER RESOLVED, that it is in the public interest that the dedication of the public way described below is accepted by the Town. The public way to be dedicated to the Town is described as follows:

A 66 foot wide road right-of-way located in Government Lot 1 of Section 5, Township 31 North, Range 26 East, Town of Gibraltar, Door County, Wisconsin and described as follows:

Commencing at the North one-quarter corner of Section 5; thence N 88°05'01" E along the north line of Government Lot 1, 1472.90 feet to the intersection with Base Line Road; thence S32°10'45" E along said centerline 1026.74 feet to the intersection with the centerline of Island Drive West and also being the point of beginning of a 66 foot wide road right-of-way being 33 feet on each side and symmetrical about the following described centerline; thence S 48°17'45" W 41.50 feet; thence S12°33'38" W 64.00 feet; thence S 04°21'38" W 57.00 feet; thence S06°37'23" E 96.00 feet; thence S19°04'02" E 98.00 feet; thence S12°19'21" E 48.00 feet; thence S05°36'56" E 34.50 feet to the intersection with the south line of Government Lot 1 and the point of termination of said centerline.

BE IT FURTHER RESOLVED, that the Town Clerk shall properly post or publish this resolution as required under s. 60.80, Wis. Stats.




