Heritage Harbor Cultural Center

The story of the Heritage Harbor Cultural Center begins in 1914, when the building at 4148 Main Street was constructed as both a home and the community's post office. The phrase "If these walls could talk" has never felt more fitting. For 111 years, this building has stood proudly on Main Street—serving as a residence, a business, and a lively gathering place at the heart of Fish Creek.

Recognizing its historic value and potential, a passionate group of community members launched an effort to transform this town-owned building into a dedicated Cultural Center. Preserving this structure is vital to maintaining the charm and authenticity of our historic downtown. Losing it—or replacing it—would dramatically alter our streetscape and diminish the unique experience that draws so many visitors to Fish Creek.

The project has already gained remarkable momentum. Pledges and donations currently cover nearly 45% of the total needed funds. Community support was further affirmed with a 68–13 town elector vote approving a long-term lease between the Town of Gibraltar and the Gibraltar Historical Association. We now enter an exciting one-year window to secure the remaining funds. Our goal is to raise \$375,000 through pledges, donations, and grants.

These funds will allow us to restore and maintain the building, establish an endowment to support ongoing upkeep, and ensure the new Cultural Center becomes a dynamic hub for preserving and sharing our community's rich history. This project is an investment not only in our past but in our future.

When complete, the Heritage Harbor Cultural Center will enhance the beauty of our downtown and provide a vital space for the Gibraltar Historical Association. It will serve as a home for historical archives, a resource for safeguarding important documents and photographs, and a meeting space for small nonprofits. Most importantly, it represents a tremendous opportunity to support meaningful growth in heritage education and community engagement.

From the Administrator's Desk

Cedar & Main Construction Update

Road and sewer improvements on Cedar Court and Main Street are scheduled to begin in mid-December. Work will continue until early January, when the project will pause for the winter and resume in the spring. The goal is to complete all upgrades before Memorial Day weekend.

Keep the charm without the harm!

The Town Board is proud of the many features that make the West Downtown Fish Creek area special—from its charming cottage shops to its unique dining experiences. At the same time, the Board recognizes ongoing challenges with access, traffic flow, and stormwater control. That's why a comprehensive street improvement plan was developed to protect the beloved tree canopy, maintain shop access, enhance walkability, and generally improve the experience for residents, businesses, and visitors.

As work begins, residents will see construction crews installing new storm sewer lines to replace collapsed infrastructure. The upgraded system will include a Vortechs® unit to help clean runoff before it reaches the bay, as well as a dry hydrant line to support rapid response for Gibraltar Fire & Rescue.

Once winter passes and the frost leaves the ground, crews will return to install new curbs, gutters, and asphalt, improving both pedestrian walkability and vehicle visibility. The project is thoughtfully designed to meander around existing trees, add protective retaining areas, create traffic-calming features, and increase visibility throughout the corridor.

The Town Board also thanks the group of dedicated citizens who assisted in shaping the final design. Their involvement has been invaluable, and the results of their efforts are now taking shape.



Fish Creek Restoration: Enhancing & Preserving our Community's Namesake Waterway

The Town has kicked off a major restoration project at the recently expanded[1] Fish Creek Park. In partnership with Stantec Consulting Services Inc.[2], improvements are underway to restore the Fish Creek stream corridor. This collaborative effort brings together science, engineering, ecological restoration, and community partnerships to enhance the function and value of the Town's namesake natural resource.

What's Happening?

- Thanks to the recent expansion of Fish Creek Park in partnership with the Redmann family[3] the property's critical habitats, including the creek's headwaters, wetlands, and old-growth forests, as well as the Niagara Escarpment bluff and its unique talus habitat at its base, will now be protected and open to the public forever.
- The goals of the restoration project are to improve stream flow, enhance fish and wildlife habitat, biodiversity, and opportunities for public recreation - creating lasting benefits for the environment and the community.
- Nearly all costs are supported by grants[4] secured by the Town in collaboration with Stantec.
- Preliminary site assessments are underway. Environmental and cultural reviews are being completed to ensure regulatory compliance and protection of critical resources.



What's Next?

- The project will occur in phases over several years. Ecosystem restoration in upland habitats is planned to start this winter. You may see crews out in the field managing invasive species (using both manual and mechanical methods) and removing fallen trees from the stream channel. Once invasive species have been sufficiently controlled, the areas will be planted with native wildflowers, grasses, shrubs, and trees.
- Ecological restoration is also underway in nearby Peninsula State Park this winter. Take a drive along Shore Rd. to get a glimpse of forest restoration similar to what is planned in Fish Creek Park – and plan to help at community tree-planting events in the spring!
- Findings from site assessments will guide recommendations for improvements to address stream flow, channel erosion, aquatic passage barriers, and decreased biodiversity. Modeling and conceptual drawings will help visualize proposed improvements.
- Engineered design plans will be developed before initiating the stream restoration. Proposed practices will prioritize streambank stabilization, improved flow, aquatic habitat, and fish passage[5]. Monitoring the system's response throughout restoration will guide adaptive management and ongoing maintenance.
- The Town and project team are committed to keeping the public informed and involved. Watch for updates and invitations to events and informational sessions as the project progresses.

If this project sounds familiar to you, it is likely because it has been years (perhaps even decades) in the making! The current initiative is building from and expanding upon the Town's long-time efforts to restore the Fish Creek corridor. The recent expansion of Fish Creek Park is indeed a 'watershed moment', offering an opportunity to influence the legacy of this critical ecosystem for generations to come.

Millrate: Calculated by dividing the tax levy for each taxing jurisdiction (limit set by legislation plus qualified debt service) by the tax base or total assessed value of the municipality.
Taxing Jurisdictions: 4 Main taxing jurisdictions, County, Municipality, Tech School, Local School District

Total Est. Fair Market Value: Estimated value calculated by the Department of Revenue and Assessor based on recent "arm length sales". Total accounts for land and improvements.

Total Assessed Value: This is the dollar value the assessor has determined for your property and the value used to calculate your total property taxes. Total accounts for land and improvements.

Ave. Assessment Ratio: Relationship between the assessed value and the equalized value of all taxable property in the municipality. When this number is 10% above or below the assessment the municipality has 5 years to adjust assessments, per Wisconsin state law.

Net assessed value: Combined mill rate of all the taxing jurisdictions, applied to the total assessed value, before credits or aids.

Lottery Tax credit/First dollar credit/school levy credit: Lottery credit offered by the state lottery for primary residence only. First dollar reduction applies to all improved properties. School levy credit is calculated by the state and applies to all taxable property. These credits reduce your taxbill.

Recently passed Referenda: If a referenda was passed it would appear here (County, school district, tech school or the municipality can pass referenda) This amount exceeds the base tax levy for that jurisdiction only with an end year.

Net property tax: Gross Property tax combined for all jurisdictions less state credits or aids.

Parks and Lands Update

2025 was a busy year for Parks and Lands as we continued encouraging visitors to enjoy our parks while planning for future improvements.

CORP Plan Nearing Completion

Our Comprehensive Outdoor Recreation Plan (CORP) is in its final stages and will be presented to the community in January. This plan outlines goals and capital improvement projects aimed at making our parks even more enjoyable for residents and visitors alike.

Fish Creek Park

We're keeping the momentum going with trail development in the upper area connecting to downtown, planting new trees, and removing invasive species—all key components of our long-term vision for the park.

Waterfront at 4148 Main Street

The future green space is beginning to take shape. For now, a simple grass lawn provides an inviting place for people to gather while larger planning efforts continue.

Sunset Park

Plans are underway for a new switchback trail to improve accessibility from Cottage Row to the water's edge. We're also addressing safety concerns related to a failing retaining wall and ongoing erosion. Each of these projects requires careful planning to ensure long-lasting, effective solutions.

Funding & Community Support

As always, progress requires resources. We are exploring grants and welcoming donations to help move these projects forward. Community members interested in supporting these efforts can learn more on our website or at upcoming Parks & Lands meetings.

Future Initiatives – Community Support and Contributions

The Committee extends its appreciation to all individuals and organizations who have contributed to benches, restoration work, and beautification projects. Community support remains an essential part of maintaining and enhancing Gibraltar's parks and lands.

Chamber Island Lighthouse

Parks & Lands continues to make steady progress in restoring the Chamber Island Lighthouse, reaffirming our commitment to preserving this historic landmark for generations to come.

This year, the lighthouse's solar system received a complete overhaul and is fully operational for the 2025 season—thanks to many donated volunteer hours. We also contracted the painting of the fascia, soffits, and exterior window frames, a challenging high-elevation project made possible by a generous donation. The work has greatly improved the lighthouse's appearance. ***Next on the schedule: replacing the decorative spires.***

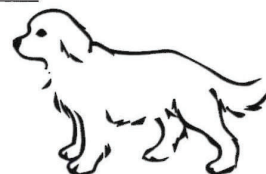
